RESOLUTION OF THE OMHA TRIBE OF NEBRASKA

RE: Relinquishment of Kain Dean DOB: 07/26/1994 Enroll#: 5928

WHEREAS, the Omaha Tribe of Nebraska is a federally recognized Indian Tribe of organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934: and

WHEREAS, pursuant to Article III, Sec. 1 of the constitution of the Omaha Tribe of Nebraska, the Governing body of the Omaha Tribal shall be known as Tribal Council: and

WHEREAS, Article IV, Sec.1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general Welfare of the Omaha Tribe: and

WHEREAS, the individual listed above wishes to relinquish enrollment with the Omaha Tribe of Nebraska and

WHEREAS, the above mentioned member is requesting that their name be stricken from the Enrollment Roll of the Omaha Tribe of Nebraska.

NOW, THEREFORE BE IT RESOLVED THAT, the Omaha Tribal Council hereby authorizes and declares and hereby accepts the voluntary relinquishment of the individual listed above from the Omaha Tribe of Nebraska.

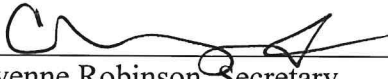
