## RESOLUTION NO. 25-103 OF THE OMAHA TRIBE OF NEBRASKA

**RE: Title 27- TERO CODE AMENDMENTS.** 

- WHEREAS The Omaha Tribe of Nebraska is a federally recognized Indian tribe organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936 pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- **WHEREAS**, pursuant to Article III, Section 1 of the Constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall be known as the Tribal Council; and,
- WHEREAS, Article IV, Section 1(j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and
- **WHEREAS** the Tribal Council finds that it is in the best interest of the Omaha Tribe of Nebraska to approve the amendments to Title 27- Tribal Employment Rights Ordinances as follows:
  - 1. To amend:

Under Section 27-3-12 Establishment of TERO Tax and Fees

- (a) Construction Employees. Every covered employer eligible to do business within the exterior boundaries of the Omaha Reservation with a construction contract shall pay a one-time nine percent (9%) of the total of the contract.
- 2. To Add:

Under Section Title 27 Section 27-3-3 Composition of the Commission (e) The TERO Administrative Assistant will be the requester in Micro, and the TERO Commission Chairman will be the approver.

**NOW THEREFORE BE IT RESOLVED:** That the Omaha Tribal Council authorizes the Chairman of the Omaha Tribe of Nebraska to approve the amendments to Title 27- Tribal Employment Rights Ordinances as follows:

#### 1. To amend:

Under Section 27-3-12 Establishment of TERO Tax and Fees

(b) Construction Employees. Every covered employer eligible to do business within the exterior boundaries of the Omaha Reservation with a construction contract shall pay a one-time nine percent (9%) of the total of the contract.
