OMAHA TRIBE OF NEBRASKA

RE: *Approval of Amendments to Title 31 of the Omaha Tribal Code*

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Omaha Tribal Council, pursuant to Article IV, (I)j, has the Responsibility to safeguard, promote and enforce the peace, economy, safety, law and order, and general welfare of the Tribe and the Omaha Reservation; and

WHEREAS: pursuant to its authority, the Omaha Tribe of Nebraska approved Title 31 of the Omaha Tribal Code, Limited Liability Companies, pursuant to Resolution No. 08-23 (12-06-07) and,

WHEREAS: the Tribal Council desires to make amendments to Title 31 of the Omaha Tribe of Nebraska Limited Liability Company Code in order to adopt provisions for formation of Tribally-owned LLCs; and,

WHEREAS: the Tribal Council finds that these amendments are in the best interest of the Tribe and its members

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council hereby approves amendments to the following sections of Title 31, as fully set forth in the attached Exhibit A hereto:


BE IT FURTHER RESOLVED THAT: These amendments shall become effective immediately.
