RESOLUTION NO. 25-OF THE OMAHA TRIBE OF NEBRASKA

RE: 25-120

Tribal Farm Enterprise SSBCI Loan

- WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- WHEREAS: pursuant to Article III, Sec. 1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and
- WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and
- WHEREAS: The Omaha Tribe is the recipient of an allocation under the US Treasury's Program known as the State Small Business Credit Initiative (SSBCI) which provides funding for loans to Tribal member owned businesses and Tribal enterprises to leverage matching loans from outside capital sources; and
- WHEREAS: The Omaha Tribe's farming enterprise, known as Against the Current Farms, has been established to manage the Tribe's farmlands and is eligible for a loan under the SSBCI program; and
- WHEREAS; Against the Current Farms will be financing the purchase of irrigation equipment for Tribal farmland and has been approved for an equipment loan from Charter West to meet half of the capital requirement, and an SSBCI loan in the amount of \$400,000 has been requested; and,
- NOW THEREFORE BE IT RESOLVED: That the Omaha Tribal Council approves an SSBCI loan to the Tribal enterprise, Against the Current Farms, for the financing of irrigation equipment and authorizes the Tribal Chairman to execute the documents required to implement the Omaha Tribe's SSBCI program and loan to Against the Current Farms which are attached hereto and include: 1- Grow American Administrative Agreement; 2-Big Elk (BEDI) SSBCI Memorandum of Understanding; 3- Certification 1 re Borrower Use of Proceeds; 4- Certification 2 re Lender Use of Proceeds; 5- Certification 3 re Sex Offender Registry; 6- Certification 5 re SEDI-owned business document; 7- Certification re SSBCI demographic data; 8- SSCBI Privacy Notice
