OMAHA TRIBE OF NEBRASKA

- **RE:** Approval of Memorandum of Agreement between the Omaha Tribe of Nebraska and Big Elk Development Corporation to Staff, Market and Implement the SSBCI Program
- WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- WHEREAS: pursuant to Article III, Sec. 1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and
- WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and
- WHEREAS: the Omaha Tribe of Nebraska is the recipient of Small State Business Credit Initiative (SSBCI) funds to operate a Loan Participation Program to provide credit support for tribal member-owned small businesses and jobs for members of the Tribe and residents of the surrounding community in business areas including renewable energy, construction, technology, and agriculture industries; and
- WHEREAS: Big Elk Development, Inc. is a non-profit entity serving the Omaha Tribe of Nebraska whose purpose is to provide housing, economic development, education, training, small-business lending to support community development and improve the quality of life for Omaha Tribal member families both on and off the Reservation; and
- WHEREAS: BEDI's purpose and OTN's approved SSBCI loan participation program share a common goal of providing credit opportunities for tribal member-owned small businesses; and
- WHEREAS: BEDI has the skill, experience, and capacity to carry out important functions of the OTN's loan participation program on behalf of the Tribe; and
- WHEREAS: The Tribal Council finds that it is in the best interest of Tribe to enter into a Memorandum of Agreement between the Omaha Tribe of Nebraska and Big Elk Development Corporation for these purposes and as set forth in the attached Exhibit A.
- NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council hereby approves the attached Exhibit A, Memorandum of Agreement between the Omaha Tribe of Nebraska

and Big Elk Development, Inc.

BE IT FURTHER RESOLVED THAT: Chairman Jason Sheridan, or, in his absence, Vice Chairman Leander Merrick is hereby authorized to take all action necessary to execute this Resolution
