WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the

welfare of the Omaha Tribe; and,

with Tribal Roll Number 10106.

### 2. Standing Rock Update


- According to council travel is limited and must pertain to job position
