### OMAHA TRIBE OF NEBRASKA

**RE:** OMAHA TRIBE GSA SCREENERS – Tamara Parker, Richard Hastings, Monique Parker, Justin McCauley, Arnold Harlan, and Janelle Hernandez

**WHEREAS:** The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

**WHEREAS:** Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

**WHEREAS:** the Omaha Tribe have granted authority for individuals to screen excess property as listed in the Federal Management Regulations (FRM) 102-36.90 through 102-36.120. The following authorized Omaha Tribe Employees are under contracts of Real Estate, Road Maintenance, Law Enforcement and Wildlife and Parks can utilize GSA equipment: Tamara Parker, Richard Hastings, Monique Parker, Justin McCauley, Arnold Harlan, and Janelle Hernandez; and

**WHEREAS:** any resolutions regarding GSA screens prior to this Resolution are rescinded; and




