WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the

governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: pursuant to Article IV, Sec. 1 (g) of the constitution of the Omaha Tribe of Nebraska the

governing body of the Omaha Tribe shall also be known as Tribal council; and

WHEREAS: the Omaha Tribe has eleven (11) applicants that meet the requirement of 1/4 (25%)

Omaha Blood,

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and,

**WHEREAS:** the Supplemental Roll 155 will now start with the Tribal Roll Number 10084, and will end with Tribal Roll Number 10094.

NOW THEREFORE, BE IT RESOLVED THAT: the Omaha Tribal Council hereby authorizes and declares that the applications for Supplemental Roll 155 are complete and ready for approval by the Omaha Tribal Council as per the Omaha Tribe of Nebraska Constitution and By-laws, Amendment II, Eligible for Enrollment.
