RESOLUTION NO. 25-93 OF THE OMAHA TRIBE OF NEBRASKA

RE: *Supplemental Roll # 155*

WHEREAS: The Omaha Tribe of Nebraska is federally recognized Indian Tribe of organized under a constitution and by-laws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: pursuant to Article IV, Sec. 1 (g) of the constitution of the Omaha Tribe of Nebraska the governing body of the Omaha Tribe shall also be known as Tribal council; and

WHEREAS: the Omaha Tribe has eleven (11) applicants that meet the requirement of $\frac{1}{4}$ (25%) Omaha Blood,

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and,

WHEREAS: the Supplemental Roll 155 will now start with the Tribal Roll Number 10084, and will end with Tribal Roll Number 10094.

NOW THEREFORE, BE IT RESOLVED THAT: the Omaha Tribal Council hereby authorizes and declares that the applications for Supplemental Roll 155 are complete and ready for approval by the Omaha Tribal Council as per the Omaha Tribe of Nebraska Constitution and By-laws, Amendment II, Eligible for Enrollment.


NOW THEREFORE, BE IT FURTHER RESOLVED THAT: the Omaha Tribe authorizes the applications will be entered into the Omaha Tribal Enrollment books with the assigned Tribal Roll Number of 10084 with the last name Cook and ending with the assigned Tribal Roll Number 10094, with the last name of Wolfe. This will be the Omaha Tribe of Nebraska Enrollment Supplemental Roll 155.

CERTIFICATION


