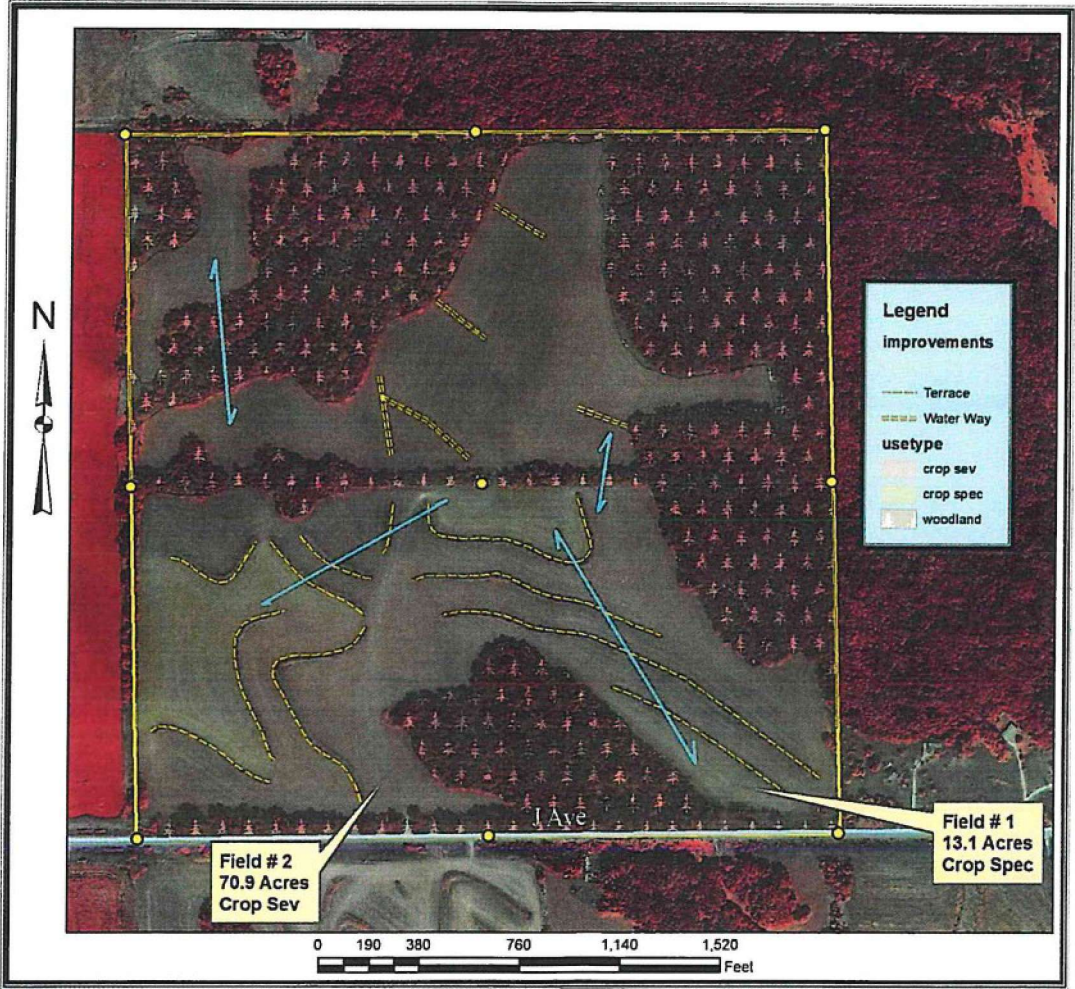

LEGAL DESCRIPTION: W ½ SE ¼ SW ¼ (625-1) & SW ¼ SW ¼ (625-2)) & E ½ SE ¼ SW ¼ (625-3) & N ½ SW ¼ (T3019) **SECTION:** 11 **TOWNSHIP:** 25 **NORTH RANGE:** 9 East 6TH **PRINCIPAL MERIDIAN.** APPROXIMATELY: 160 ACRES. OF WHICH 84 MAY BE CULTIVATED. (SEE MAP BELOW FOR DELINEATION OF FARMABLE LAND).

SPECIAL PRACTICES: (1.) LESSEE SHALL CONTROL BRUSH AND VOLUNTEER TREES FOR TERM OF LEASE. CONSIDERED AS HARMFUL GROWTH. (2.) LESSEE SHALL CONTROL ALL NOXIOUS WEEDS FOR THE FULL TERM OF THIS LEASE. (3.) TERRACE REPAIR AND ENLARGEMENT REQUIRED WITHIN THE FIRST TWO YEARS OF THIS LEASE. (4.) ESTABLISH AND MAINTAIN ALL WATERWAYS AS SHOWN. (5.) STOCKING RATE, IF SPECIFIED, SHALL BE STRICTLY ADHERED TO. OVERSTOCKING SHALL BE CONSIDERED TO COMPRISE OVERUSE. (6.) NO USE SHALL BE MADE OF AREA FOR WHICH NO AUTHORIZATION IS GRANTED. USE OF SUCH AREAS SHALL BE GROUNDS FOR CANCELLATION OF LEASE. (7.) DUE TO PROVISIONS OF THE MIGRATORY BIRD TREATY ACT, NO BRUSH OR TREE REMOVAL IS PERMITTED BETWEEN APRIL 1ST AND JULY 15TH OF ANY GIVEN YEAR. (8.) AREAS DESIGNATED AS NO TILL SHALL NOT BE TILLED FOR PLANTING OF CROPS. (9.) MAINTAIN ALL TERRACES AND ALL WATERWAYS TO NRCS SPECIFICATIONS IMMEDIATELY AND FOR THE FULL TERM OF THIS LEASE. (10.) MOW R.O.W. AT LEAST TWO TIMES PER GROWING SEASON. (11.) *Close Sown High Residue Small Grain or Alfalfa - CSHRSG*
