MICRO-TRIBAL LICENSE (PERSONAL, NON-COMMERCIAL) APPLICATION

This packet is only for the Micro-Tribal License, which authorizes limited personal cultivation and possession by enrolled Omaha Tribal Members. It does not authorize any commercial activity or sales.

PART 1 – GENERAL INFORMATION

1. Purpose

The Micro-Tribal License allows eligible Tribal Members to cultivate and possess limited amounts of cannabis for personal use, subject to plant and possession limits and safety requirements adopted by the Commission.

2. Who May Apply

- a. Only enrolled Omaha Tribal Members who are at least 21 years old.
- b. Non-members and entities are not eligible for this license.

3. Non-Commercial Use Only

- a. The Micro-Tribal License does not authorize any commercial activity.
- b. No sales, trades, or remuneration of any kind are allowed.
- c. Any commercial activity requires a separate commercial license under Tribal law.

4. Term and Renewal

- a. The Micro-Tribal License is valid for one (1) year from the date of issuance.
- b. It may be renewed annually by submitting an updated application and renewal fee.

5. Compliance and Enforcement

- a. License holders must follow all applicable Tribal laws and Commission regulations.
- b. Violations may result in license suspension or revocation, and other enforcement actions as allowed by Tribal law.
